

| Saudi | - Individual DPMs | Saudi individual investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them). | | | | | |
| Sauui | Institutions | Saudi Institutions have been classified under 4 categories as defined below: | | | | | |
| | - Corporates | Saudi company with a commercial registration permitting its investment in the stock market . | | | | | |
| | - Mutual Funds | A mutual fund managed by an Authorized Person and licensed by the CMA. | | | | | |
| | - Government Related Entities (GREs) | A Government entity or a supranational authority recognized by the CMA. | | | | | |

| | SWAP Holders | Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients. | | | | | |
| Foreign | Foreign Residents | Foreign investors domiciled in the Kingdom with a valid residency permit (Iqama) (excluding GCC nationals). | | | | | |
| | QFIs | Qualified Foreign Institutional investors registered with the CMA in accordance with the QFI Rules, to invest in shares listed on the Saudi Stock Exchange. | | | | | |

Highlights




The total value of shares traded for the week ending 8 June 2017 amounted to SAR 15.76 billion, increasing by 57.40% over the previous week; while total stock market capitalization reached SAR 1,624.24 billion at the end of this period, increasing by 0.20% over the previous week.



- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 14.79 billion representing 93.83% of total buying activity, and sales of SAR 15.04 billion representing 95.41% of total selling activity. Total ownership of "Saudi Investors" stood at 93.50% of total market capitalization as of 8 June 2017, representing an increase of 0.01% from the previous week.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 0.280 billion representing 1.78% of total buying activity, and sales of SAR 0.275 billion representing 1.74% of total selling activity. Total ownership of "GCC Investors" stood at 2.26% of total market capitalization as of 8 June 2017, representing a decrease of 0.02% from the previous week.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 0.693 billion representing 4.39% of total buying activity, and sales of SAR 0.449 billion representing 2.85% of total selling activity. Total ownership of "Foreign Investors" stood at 4.23% of total market capitalization as of 8 June 2017, representing an increase of 0.01% from the previous week.


Institutional:

Non Institutional:

Refers to investors with non-institutional behavior including Saudi Retail Investors, Saudi High Net Worth Investors (HNWI), GCC Individuals and Foreign Residents.
