





	- High Net Worth Investors (HNWIs)	HNWIs are Saudi individuals who have had an average portfolio size of SAR 1m (and above) for the preceding 12 months, excluding IPIs (see below).					
	- Individual Professional Investors (IPIs)	IPIs are Saudi individuals who have had an average portfolio size of SAR 50m (and above) for the preceding 12 months and a portfolio turnover rat of not more than 4 times annually.

- Worked for at least 3 years in financial sectors.
- Hold General Securities Qualification Certificate which is recognized by the Authority.
- Holds professional certificate that is related to securities business and accredited by an internationally recognized entity




The total value of shares traded for the month ending 31 January 2019 amounted to SAR 68.21 billion, Increasing by 13.42% over the previous month; while total stock market capitalization reached SAR 2,025.17 billion at the end of this period, increasing by 8.97% over the previous month.



- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 57.75 billion representing 84.66% of total buying activity, and sales of SAR 62.77 billion representing 92.02% of total selling activity. Total ownership of "Saudi Investors" stood at 93.00% of total market capitalization as of 31 January 2019, representing a decrease of 0.35% from the previous month.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 2.17 billion representing 3.18% of total buying activity, and sales of SAR 1.51 billion representing 2.22% of total selling activity. Total ownership of "GCC Investors" stood at 2.01% of total market capitalization as of 31 January 2019, representing an increase of 0.04% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 8.29 billion representing 12.16% of total buying activity, and sales of SAR 3.93 billion representing 5.76% of total selling activity. Total ownership of "Foreign Investors" stood at 4.98% of total market capitalization as of 31 January 2019, representing an increase of 0.31% from the previous month.






The total value of shares traded for the month ending 31 January 2019 amounted to SAR 41.62 million, decreasing by 8.45% over the previous month; while total stock market capitalization reached SAR 3,283.80 million at the end of this period, increasing by 41.27% over the previous month.



- The total value of shares purchased by "Saudi Investors" during this period amounted to SAR 39.60 million representing 95.15% of total buying activity, and sales of SAR 38.86 million representing 93.38% of total selling activity. Total ownership of "Saudi Investors" stood at 99.09% of total market capitalization as of 31 January 2019, representing an increase of 0.37% from the previous month.
- The total value of shares purchased by "GCC Investors" during this period amounted to SAR 0 million representing 0% of total buying activity, and sales of SAR .51 million representing 1.24% of total selling activity. Total ownership of "GCC Investors" stood at 0.40% of total market capitalization as of 31 January 2019, representing a decrease of 0.17% from the previous month.
- The total value of shares purchased by "Foreign Investors" during this period amounted to SAR 2.02 million representing 4.85% of total buying activity, and sales of SAR 2.24 million representing 5.39% of total selling activity. Total ownership of "Foreign Investors" stood at 0.51% of total market capitalization as of 31 January 2019 representing a decrease of 0.20% from the previous month.
